About the information you provide

- I understand that the Trustees of ITV's benefit schemes hold personal data which I've provided to them. They need this to be able to administer my benefits under the schemes.
- The Trustees, who are data controllers for data protection purposes, are required to look after my personal data in line with legal requirements. This means the Trustees are responsible for deciding what personal information needs to be processed and the way in which the information is processed.
- In processing my personal data, the Trustees may need to pass personal information about me, my dependants and other members and beneficiaries, to the schemes' administrators, auditors, legal advisers, insurers, insurance companies or other occupational pension schemes and their advisers with a view to securing benefits or making or receiving a transfer of benefits, and to the ITV group of companies and other third parties that are necessary to administer the schemes.
- Each scheme has a more detailed statement called a privacy notice explaining how the data will be used. The privacy notice explains the personal data the Trustees hold, how they use that information and who they share it with. The privacy notices are updated from time to time in line with changes to data protection legislation and scheme practices. The privacy notices also set out your rights about the personal data held about you by the Trustees and who to contact if you want to exercise those rights, make a complaint or have any questions.
